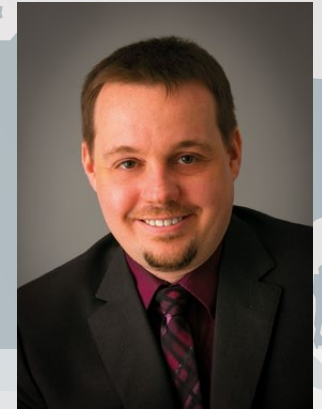

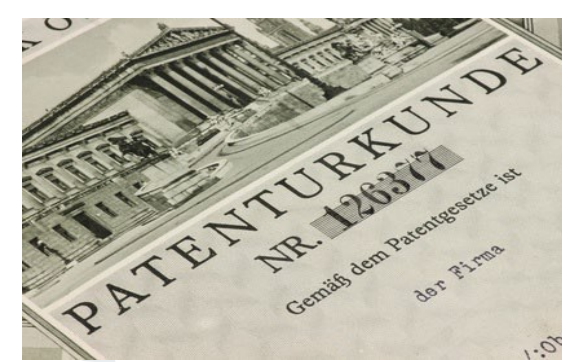
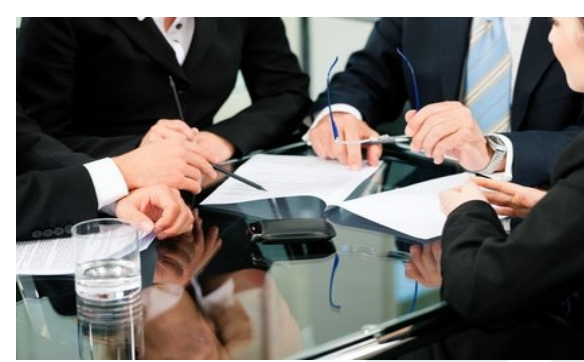

Valuation

> Patent valuation, IP valuation, including licences, company valuation based on DCF analysis, multiple analysis, and comparable transaction analysis; assessment of cost of capital and WACC, review and evaluation of investment decisions

Commercialization / Monetization

> Marketing of international patent portfolios, licensing of patents and other IP rights, assessment / development of commercialization strategy, identification of possible licensing partners or potential strategic partners / buyers, Project management and implementation

M&A Strategy and M&A Implementation

> Review / development of M&A strategy, project management and process implementation, Organization of due diligence, IP due diligence, assistance in business development, strategic partner search (technology, distribution), acquisition target search, approach and negotiations, post merger integration of patent / IP portfolio

Strategic Advisory

> Adhoc advisory or project advisory with regard to strategy and strategic business development and corporate development with strong focus on IP related questions.
